This is a US government sponsored program and consisted of a forgivable loan to Strata specifically designed to help businesses keep their workers on the payroll during the COVID-19 pandemic.</p> <p>In accordance with this program Strata applied for and received approval for this loan and accrued interest to be 100% forgiven during the December 2020 quarter.
